Course Overview:

This course will increase students' understanding of the diverse personal, socio-cultural, and institutional factors that influence health, physical activity, and nutrition-related behaviors, and ultimately intervention design and approach. The course will cover the social determinants of health and health disparities, theoretical models of health behavior change, and intervention/behavior change strategies and tools. Students coming away from this course will have a better understanding of how to apply health behavior change models to promote physical activity and healthy behaviors *in diverse populations through tailored interventions*.

Course Objectives:

By the conclusion of the course, students will be able to:

1. Identify of how various individual, interpersonal, institutional, and socio-cultural factors influence health and health behaviors in diverse populations
2. Apply prominent theoretical models of health behavior change across levels of the socioecological model to improve health in diverse populations
3. To demonstrate how knowledge of the social determinants of health, health disparities, and theory can impact health in diverse populations through research and/or practice

Assigned Readings:

There is no required textbook for this course. All assigned readings will be posted on Canvas or made available through the Hillman Library.

Course Grading:

The assignments for this course are designed to give you opportunities to reflect on your learning and to structure your weekly participation in the course. Assignments are also opportunities for you to receive feedback on your progress and performance. Additional details for each course assignment will be available in Canvas.

Attendance and Participation

Given the dynamic, discussion-based format of this graduate level class, regular and prompt attendance in the class sessions is essential. You are expected to read the assigned articles prior to class, to participate in discussions with your peers and be engaged in class activities. On the days when we have guest speakers or visit facilities, you are expected to attend and participate in the session: *Class participation will be assessed during each class session based on the criteria:*

1. Contribute effectively to class discussion or activities by commenting, asking questions, answering questions, participating in small group work or discussions and/or completing in-class activities.
2. Contributions should advance the academic conversation in-class.

Reflective Practices

Sometimes, weekly reflections will be assigned. Reflections will be due by class time (5:30pm on Mondays). These reflections are worth 5 points each and account for 10% of your overall grade in this course. For the reflections, your responses should be equivalent to approximately 1-2 pages, double-spaced, Times New Roman 12 font, with normal margins and proper citation (APA). Completeness and quality of journal reflections will be evaluated based on the following criteria: Responsiveness, Communication, Critical Thinking and Analysis, and Mechanics. A grading rubric will be posted on Canvas with more detail about how to earn the full 5 points.

Web of Causation/Psychosocial Map

This assignment requires the student to think critically about the complexities that exist within one condition/illness for a specific population. The creation of this graphic will require researching the many complexities of that condition and offers ideas for how to intercept in the care of that condition utilizing the social determinants of health and psychosocial aspects of care.

Research and Application Paper

For this paper, you will choose to research (1) a disease/condition and (2) a marginalized population and the interaction between those two. You will critically evaluate current care of that condition for the population and create a framework for a future or current place of practice to educate peers/staff/colleagues about how to

generate an inclusive environment to promote health equity. As part of this assignment, you will complete a peer review of a fellow students' paper to engage in the peer review process and to help to better prepare your own paper for completion/submission.

Final Presentation

Your final presentation will be a culminating project that will apply and synthesize concepts and knowledge gained over the semester. Specifically, the project will demonstrate your understanding of social determinants of health, health disparities, and how to impact health of diverse populations through research and/or practice. The final two classes of the semester will be reserved for presenting your final group project and celebrating your work to date.

Gender Inclusive Language Statement

We must avoid personal attacks and the use of ad hominem arguments to invalidate each other's positions. Instead, we must develop a culture of civil argumentation, wherein all positions have the right to be defended and argued against in intellectually reasoned ways. It is this standard that everyone must accept in order to stay in this class; a standard that applies to all inquiry in the university, but whose observance is especially important in a course whose subject matter is so emotionally charged.
